The Show Committee has met 6 times since June. A lot of behind the scene work has been done since the change of Board to help get the fall series current and ready to go. All of our awards are in compliance with our By-Laws, premium has been updated, ALL of our fall Buckles have been sponsored, our show high points have been ordered, several new ideas for 2024 have been discussed, including: potential ride all day fees, show dinners before/after the show, demonstrations and clinics held before/after show, and including ponies in our miniature horse division.
